 - **Automobile industry:** wide range of industry solutions, from suspension systems to electronically controlled powertrains
 - **Industrial vehicles:** automotive engineering solutions, with advanced expertise in suspension, chassis, axles and transmission systems;
 - **Aerospace:** structural analysis & light weighting design, engines, aircraft, etc.;
 - **Defense:** solutions and equipment to the USA military industry.

ATI also works with technologies at the core of the Segula Technologies innovation strategy, including 3D printing, optimization and weight reduction.

Through these operations, about 150 new employees will join the Segula international teams.

They will strengthen considerably the position of Segula Technologies in the USA, a year after the acquisition of Griswold.

They also reflect the will of Segula to accelerate its international development, where the group already generates 30% of its revenue.
